Release and Indemnification**

In order to participate: All contest participants must complete waiver and release from liability. Applicants under age 18 must have parent or guardian complete waiver and release from liability. Each participant in the Chasing the Sun Pow Wow must sign this form. This form may be duplicated for each participant.

Waiver & Release From Liability

1. HEREBY RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE the Chasing the Sun Pow Wow, Chasing the Sun Productions, Red Note, Inc., City of Glendale, Ak-Chin Indian Community, Phoenix Coyotes, Jobing.com Arena, Westgate City Center and its employees, the promoters, other participants, operators, officials, sponsors, advertisers, owners and lessees of premises used to conduct the event and each of them, their officers and employees, all for the purposes herein referred to as releases, from all liability to the undersigned, his personal representatives, assigns, heirs, and next of kin for any and all damage, and any claim or demands therefore on account of injury to the person or property or resulting in death of the undersigned, whether caused by the negligence of the releases or otherwise while the undersigned is in or upon the tournament facilities, and/or, competing, officiating in, observing, or working for, or for any purpose participating in the event;

HEREBY AGREES TO INDEMNIFY AND SAVE AND HOLD HARMLESS the releases and each of them from any loss, liability, damage, or cost they may incur due to the presence of the undersigned in or upon the Chasing the Sun Pow Wow event location or in any way competing, officiating, observing, or working for, or for any purpose participating in the event and whether caused by the negligence of the releases or otherwise.

3. HEREBY ASSUMES FULL RESPONSIBILITY FOR AND RISK OF BODILY INJURY, DEATH OR PROPERTY DAMAGE due to the negligence of releases or otherwise while in or upon the tournament facilities and/or while competing, officiating, or observing for any purpose participating in the event.
